ENLARGED MEETING OF THE CNRCSA EXECUTIVE COMMITTEE WITH REGIONAL REPRESENTATIVES HELD AT THE SHAPE CLUB ON WEDNESDAY 19 OCTOBER 2016 AT 09.00 HOURS

## INTRODUCTORY REMARKS

- 1. The CHAIRMAN, Mr. O. Guidetti (CNRCSA Chairman), welcomed the participants to this second meeting with regional representatives which was held back-to-back with the ANARCP Plenary meeting. He welcomed in particular Mrs. I. Tezcan (ARNS), Mr. G. Malet (ARNS), Mr. M. Geeraerts (ARNS), Mr. L. Daykin (ANARCP), Mr. G. L. Thorsen (ANARCP), Mr. T. Hammargren (ANARCP), Mr. K. van den Broek (ANARCP), and Ms. A. Egribozlu (ANARCP) who attended for the first time a meeting of the Executive Committee. He extended his special thanks to the ANARCP Chairman and Secretary for their much appreciated help in organizing this meeting.
- 2. The CNRCSA SECRETARY, Mr. B. Roden, indicated that apologies for absence had been received from the following members: Mr. J. Devaux (AROF), Mr. R. Goyens (AROF), Mr. A. Grant (ARNS), Mrs. I. Waerschburger (NOBA), and Mr. J. F. Eiken (ANARCP).
- 3. He further stressed that all documents included in the reference file for the meeting should be considered as classified material and not be widely circulated.
- 4. The COMMITTEE noted the introductory remarks by the Chairman and the Secretary.
- I. APPROVAL OF THE AGENDA

## II. RECORD OF THE PREVIOUS MEETING

6. The COMMITTEE noted that the record of its previous meeting had been approved under a silence procedure ending on 31 August 2016.

## III. FOLLOW-UP TO DECISIONS MADE

7. The COMMITTEE noted that all decisions made at the previous meeting had been followed-up, with the exception of action item 6/31 (Meeting of Associations' webmasters) on which further information would be provided later in the meeting.

## IV. APPOINTMENTS TO THE (ENLARGED) EXECUTIVE COMMITTEE/RESIGNATIONS

- 8. The COMMITTEE noted that the silence procedure followed for the CNRCSA Bureau elections had not been broken and, in accordance with the Articles of Association, reappointed Mr. H. Rutten (Vice-Chairman) and Mr. E. Marquenie (Treasurer) for a two years' term of office.
- 9. The COMMITTEE noted that the following new members had been appointed by their parent Associations to sit on the CNRCSA Executive Committee: Mrs. I. Tezcan (ARNS), Mr. G. Malet (ARNS), Mr. R. Hickman (AROF), Mr. J-M Torrès (AROF), and Mr. L. Daykin (ANARCP). It also noted that Mr. J. Delor (ANARCP) had resigned, due to other commitments, and thanked him for his contributions.
- 10. The COMMITTEE formally appointed the following new Regional Representatives: Ms. A. Egribozlu (ANARCP) for Turkey, Mr. G. L. Thorsen (ANARCP) for Denmark, and Mr. G. Franzreb (ANARCP) for France.

11. The COMMITTEE took note of the resignations of Mrs. L. Hoffman-Jensen (ANARCP), Regional Representative for Denmark, and of Mr. R. Neitzel (ANARCP), Regional Representative for Germany. The Committee thanked them both for their invaluable work to the cause of NATO retirees and wished them well for the future. The Committee also noted that Mr. F.Bülling, in his capacity of Chairman of the CNRCSA WG on Policy Insurance Matters, would resign from this function end 2017. However, he would remain member of the ANARCP and the CNRCSA Executive Committees in accordance with the relevant regulations until 2020.

## V. FINANCIAL MATTERS

- (a) Draft 2017 Budget
- 12. The COMMITTEE took note of the verbal report by the Treasurer and approved, without comments, the 2017 budget as reproduced in a document distributed at the beginning of the meeting.
  - (b) <u>International Staff Subsidy for 2016</u>
- 13. The COMMITTEE noted that the subsidy for 2016 (14,000 euros) had been approved by Executive Management and would be transferred to the CNRCSA bank account.
  - (c) Call for contributions

- 14. The COMMITTEE noted the Treasurer's statement indicating that all Associations had paid their contributions (2 Euros per member), with the exception of AROF for which banking arrangements needed to be finalized.

- 15. The COMMITTEE took note of the verbal report by the Treasurer indicating that the meetings had focussed on the definition of the Treasurers' role, the sources of financing (contributions and IS subsidy), the management of incoming and outgoing funds, and the auditing procedures.
- 16. It was agreed that the Treasurers' meetings contributed to the harmonization of the Associations' accounting and auditing procedures, and the Treasurer was tasked to organize other meetings of the same kind (Action 1).
- VI. REORGANIZATION OF THE CNRCSA STRUCTURE AND WORKING METHODS

17. The COMMITTEE discussed the proposals made by the AHWG and agreed, with the unanimous support of the Associations' Chairmen, that it was needed to better react to the fast and complex NATO decision-making process and prevailing budget constraints, and also to provide an improved service and support to the increasing number of retirees who are joining the CNRCSA constituent Associations. For this purpose, efforts and resources should be centralized and the administration of the Associations should be streamlined to support the CNRCSA in the areas of budget and finance, public relations and website, administration and update of a centralized members' database. It was understood that each Association's autonomy should be maintained.

## 18. The COMMITTEE could support the following proposals:

- (a) The Associations' membership forms should be harmonized under the heading of the CNRCSA.
  - (b) The Associations' membership fees should be set at the same level.
- (c) The CNRCSA Secretariat should establish and update, with the help of the Associations' secretaries, a single membership data base.
- 19. The COMMITTEE tasked the Regional Representatives to provide their comments on the AHWG report (Action 2), and requested the AHWG to take the measures needed to implement the above proposals, with the involvement of the Treasurer, the Associations' secretaries and other knowledgeable volunteers, and to further discuss the feasibility of the proposals below:
- (a) The CNRCSA should hold a yearly General Assembly of its four Associations' members where focal points on group insurance, pensions, and legal issues would present update reports.
- (b) The ANARCP National Delegates' structure should merge with the CNRCSA Regional Representatives' structure. Financing of the latter travel and missions in the future should be sought through NATO (Action 3).

#### VII. UPDATE ON HEALTH INSURANCE MATTERS

(a) Visit to AWC Brussels Headquarters on 4 July 2016

- 20. The COMMITTEE noted that this item was raised pro memoria, as it had already been covered at its last meeting (see CNRCSA(2016)R/2, VII(i).
  - (b) NATO Group Insurance Contract 2017

21. The COMMITTEE noted that the re-written NGIC 2017 was pending approval by the Assistant Secretary General for Executive Management since December 2015. Despite several requests for clarification, NATO Personnel Support Services (NPSS) were unwilling to give further details. It should be noted that the re-written NGIC 2017 had not been co-ordinated with the CNRCSA, the CNCSC, the Advisory Panel on Administrative Matters and the JCB. NPSS considered this document was a management tool which did not require any coordination/consultation with a third party.

22. The COMMITTEE could not accept that the NGIC should be modified without consultation of or co-ordination with the JCB, and tasked its representatives to raise the matter at the next meeting of the JCB and of its Working Group on Insurance Matters (<u>Action</u> 4).

## (c) NATO-wide Implementation Guidelines (NGIC)

- 23. The COMMITTEE noted that this document had been approved by the JCB in its initial version on 4 June 2013. Since then, NPSS had started implementing several amendments and changes which had been co-ordinated internally with AWC without being formally approved by the JCB.
- 24. The COMMITTEE tasked its representatives to request, at the next meetings of the JCB and of its WG on Insurance Matters, that the amended Guidelines be approved by the JCB (Action 5).

## (d) NATO Benefit Guide 2016

25. The COMMITTEE noted that despite several reminders, NPSS had not changed its policy concerning the distribution of a hard copy of the Guide to all insured retirees, although promises had been made by AWC in December 2013 to do so.

## (e) NATO-wide Supplementary Insurance (NWS)

26. The COMMITTEE noted that the JCB had agreed, at its last meeting, that NPSS would provide relevant data to the Confederation of NATO Civilian Staff Committees (CNCSC) to enable the policyholder to come forward with proposals for streamlining the NWS. The Committee regretted that these data would only be provided to the CNRCSA via the next JCB WG on Medical Insurance Matters and not directly.

#### (f) Primary Insurance

27. The COMMITTEE noted that NPSS and AWC had agreed in 2015 that the AWC database including all insured active and former staff members who were affiliated to another insurance was lacking completeness and should be updated. The Committee regretted that this had still not been followed up.

28. The COMMITTEE noted that the procedures to be followed for lodging a complaint against the claim handling service of AWC needed clarification. A complainant may avail himself, in present circumstances, of three possibilities: the internal system of AWC of which he is not fully aware, article 7 of the NGIC to which he has no access, and the complaint procedure mentioned in the CPRs. Which procedure takes precedence is not clear. The Committee tasked, therefore, its representatives to raise the matter at the next meeting of the relevant JCB Working Group (Action 6).

## VIII. CHANGE TO FOOTNOTE TO ARTICLE 51.2 OF THE CPRS/COMPLAINT

29. The COMMITTEE noted with deep concern that the complaint, financially supported by the CNRCSA, had been lodged on 28 May 2016 within the deadline set in the CPRs, but that the Secretary General had still not convened the Complaints Committee to deal with the matter.

## IX. JOINT CONSULTATIVE BOARD

## (a) JCB meeting held on 7 July 2016

30. The COMMITTEE took note of the report on the meeting, which was included in the reference file.

## (b) JCB meeting to be held on 20 October 2016

- 31. The COMMITTEE agreed the CNRCSA position on the items that would be discussed at the next meeting of the JCB, i.e. defined contribution pension scheme, single salary spine, complaints and appeals procedure, and officially registered civil partnerships.
- 32. The COMMITTEE noted that the next JCB meeting would be chaired by the new DASG for Human Resources, Mr. P. Billaud-Durand, and tasked the Bureau to organize a first meeting with him and formally invite him to attend the next meeting of the Executive Committee (Action 7).

- 33. The COMMITTEE took note of the report of the JCB Working Group and reaffirmed its position: failing an in-depth review of the NATO complaints and appeals procedures, which are basically flawed as far as retirees are concerned, the CNRCSA would plea for a return to the old system for retirees. Some NATO Administrations could support this position.
- 34. The COMMITTEE agreed, however, to work with the CNCSC which had made a good proposal aimed at doing away with Complaints Committees and replacing them with a conciliation process between all parties involved in a contested decision. Should conciliation fail, the matter would then be referred to an external judge, whose decision could be appealed against in an Appeals Board. This would provide NATO with a two-tier judicial system.

#### X. DEFINED CONTRIBUTION PENSIONS SCHEME (DCPS)

35. The COMMITTEE took note of the proposals that had been made by NATO to improve the DCPS and firmly supported the CNCSC which maintained that the proposed measures were far from sufficient to consider the DCPS a 'real' pension scheme and which requested that a real study be undertaken that should focus on the pension schemes in the eight reference national civil services and in other Coordinated Organisations, and should be based on a

defined benefits approach as was the case in the other Coordinated Organisations' new pension schemes.

36. The COMMITTEE was informed that the IT team managing the website would convene a meeting of all Associations' webmasters by Skype in November whose purpose would be to firm up a meaningful approach towards a common website policy, to define the process for updating users of the website, and to identify other issues that needed to be addressed.

## XII. CNRCSA REGIONAL REPRESENTATIVES' ANNUAL REPORTS

37. The COMMITTEE took note of the first annual reports of the CNRCSA Regional Representatives which indicated that pension taxation was the main issue they had to deal with in their respective countries.

- the Secretary to re-issue the Regional Representatives' Terms of Reference (Action 9)
- each Association's secretary to provide Regional Representatives with an updated list of association's members residing in the countries for which they were competent (**Action 10**)

#### XIII. CCR-RELATED MATTERS

(a) Annual adjustment of remuneration at 1 January 2017

- 39. The COMMITTEE noted that three nations in the NATO Council had broken silence on the CCR 2017 annual adjustment of remuneration proposal.
  - (b) New adjustment of remuneration method

40. The Committee took note of the latest developments concerning the new method at the CCR level in which the nations initially proposed to include a moderation clause over and above the affordability clause. The CCR ultimately agreed to adopt a method for a period of four years without including a special moderation clause, provided that the three Committees committed themselves to "address the concerns expressed by a few CCR delegations that have difficulty in justifying in their capital the results of the application of the salary adjustment method" by June 2017. The CRP/CRSG could support this compromise solution.

## XIV. AAPOCAD

(a) Mr. V. Arzeni's proposal to change the wording of the Co-ordinated Pension Scheme as included in the CPRs

- 41. The COMMITTEE noted that its representatives sitting on AAPOCAD Governing Board, as tasked at the last meeting, had requested that the proposal be discussed at the next meeting of the Board. Members of the Board could not support the proposal which they considered to be risky and counter-productive at the time where the CCR was planning to review basic tenets of the 1974 Pension Scheme (tax adjustment among others). The Committee shared this position.
